**FOSTER AGREEMENT CONTRACT**

I/we \_\_\_\_\_ (name(s)) fully understand that I/we agree to act as a Foster Home for RottweilerRescue Society. The following conditions apply to fostering RottweilerRescue Society Dogs while in my care and in my home.

1. The animal (s) will reside only in the house of the foster and must be inside when foster is not home. The animal (s) will be outside in a fenced yard only when the foster can supervise the animal (s). The animal (s) will remain the property of RottweilerRescue Society and will be surrendered to an officer of liaison of RottweilerRescue Society immediately on request.
2. The animal (s) will be fed, watered and exercised appropriately on-lead, and off-lead only when in a secure kennel or fenced yard. Prong collars or choke collars are to be used only while walking or training the animal (s). The foster home will not be compensated for expenses incurred in the normal daily care of the animal (s). All RottweilerRescue Society dogs must receive monthly heartworm preventative (as well as flea preventative) unless they are undergoing treatment. Upon finishing heartworm treatment, RottweilerRescue Society dogs must be started on preventative. This will be provided if foster cannot afford it.
3. Veterinary care will be provided by RottweilerRescue Society. This includes vaccinations, heartworm testing, altering and any prescription medications necessary for the dog. Any expenditures incurred by the foster family other than emergency care and treatment require prior approval before RottweilerRescue Society will reimburse. The foster family will be held responsible for unapproved expenditures. The foster family will also be held responsible for any expenses incurred on behalf of the animal (s) that resulted directly from the foster family's negligence.
4. The animal (s) is/are to be adopted to its permanent home only under the supervision of RottweilerRescue Society to a family pre-approved by RottweilerRescue Society. Adoptive families may be contacted by the foster family to inquire about the animal (s), however, adoptive families are allowed respect and privacy. Excessively casual or excessively aggressive contacts with the potential and actual adoptive families are not desired.

5. All donations connected with the adoption of the animal (s) can be paid through paypal.
6. Any questions or problems are to be directed to [admin@rottweilerrescuesociety.com](mailto:admin@rottweilerrescuesociety.com). If there is a need to remove the animal from the foster home, the animal (s) is/are to be given directly to a Rottweiler Rescue Society liaison.
7. The foster family accepts responsibility for any and all events that occur in connection with the fostering of a Rottweiler Rescue Society animal (s). The foster family agrees to release Rottweiler Rescue Society from any and all claims, known and unknown, now or hereafter, arising in connection with the animal (s).
8. Rottweiler Rescue Society recommends that the foster family have a crate available should its use be necessary. Crates can be provided if necessary.
9. The foster family will evaluate the animal (s) and prepare an evaluation form. The form will be kept with the adoption package as information for the new owners.
